- Your ship notice must be in our system before your shipment arrives at our store's receiving dock.
- Each shipment must have a UCC 128 label and all required zones completed, reflect the **new address listed above**, and include a valid SSCC 128 bar code providing the store the ability to scan the label upon arrival.
- The UCC 128 label must be placed on the outside of the carton, clear of any internal labels or packing slip envelope overlay.

Macy's recognizes that this is a major change for our vendors and appreciates your partnership in the initiative.
